  - Currently pursuing a Doctor of Education in Higher Ed, Leadership and Organizational Studies at Bay Path University.
- Previous role:
  - Served as D.E.I. manager and ADA coordinator at the Massachusetts Executive Office of Energy and Environmental Affairs.
  - Focused on diversity programming, affirmative action, compliance, and workforce equity initiatives.

Committee Chair Tessa Lucey called the meeting to order at 10:46 AM and a roll call was taken of the committee members participating as listed above. It was announced that the meeting was being livestreamed and recorded.

#### **Enrollment Data for Underrepresented Populations**

Director of Belonging, Inclusion and Learning, Jenyka Spitz-Cassnola, reviewed demographic data trends from 2019-2023 which covered gender, race, ethnicity, disability status and veteran status.

- Summary of findings show a growth in diversity at Westfield State University.
- Undergraduate statistics show there is a decline in female status, but an increase in "other" gender identities.
- Veteran status has declined in undergraduate status but is seeing growth in the graduate levels.
- Increase in undergraduate and graduate students with disabilities.
- There is a growing need for data collection and change how we collect it.

#### Thematic Analysis Overview

Ms. Spitz-Cassnola interviewed 75 stakeholders over 12 weeks.

Created office language for Belonging, Inclusion, and Learning mission statement, views and key functions also aligned with Westfield State University's mission statement.

#### Current and New Initiatives for Belonging, Inclusion, and Learning

- Events planned by Ms. Spitz-Cassnola were successful with 40-70 attendees.
- Black History month is coming up and students are being contacted to hear their ideas of activities.
- Looking for ways to get students out of the dorm room and getting involved in activities on campus.
- Ms. Spitz-Cassnola has been working to make sure the marginalized population of students don't fall through the cracks.
- Trying to make the JEDI floor in University Hall more competitive to bring in more diverse students.
- Diversity, Equity and Inclusion (DEI) nomenclature focusing more on "belonging" to include faculty, staff, students, and all the different under-represented groups.
- Ms. Spitz-Cassnola would like, in the future, to create an interactive Key Performance Indicator.







Artists like Nina Simone, Miles Davis, and Kendrick Lamar have redefined genres, using music as a tool for social change and personal expression.


Writers like James Baldwin and Zora Neale Hurston have shaped literary history, exploring the complexities of Black identity and the African American experience in profound ways.



### BIAS EDUCATION SUPPORT TEAM (BEST)




#### During our last BEST Meeting on 1/16, the following items were discussed:
